The Parish of St John the Baptist hereby issues a Request for Qualifications (RFQ) for a firm that possesses Professional Engineering qualifications for the following purposes: (1) complete the necessary engineering, design, survey, geotechnical investigations, permitting and related services for the **Belle Terre Streetscape and Stormwater Management Enhancements** project, funded through RESTORE Act funds. Each submittal shall contain sufficient information demonstrating that the firm has Professional Engineers registered in the State of Louisiana in good standing and sufficient support staff available to complete the required tasks and documents for the proposed project.

All responses received will be evaluated in accordance with the selection criteria identified in the Request for Qualifications packet. That packet also identifies the scope of services to be performed by the selected firm.

Firms submitting a response shall provide a submittal package following a format based on the designated evaluation criteria. Applicants shall include sufficient information about the firm's qualifications which demonstrates the proper capabilities for implementation of the proposed project.

Qualification Statements must be submitted, along with the Standard Form SJB-1000 (Belle Terre Streetscape and Stormwater Management Enhancements), in a sealed envelope to the Purchasing & Procurement Department, 1811 W. Airline Highway, LaPlace, LA 70068. The sealed envelope shall be clearly marked "RFQ-2019-03 – Belle Terre Streetscape and Stormwater Management Enhancements." Submissions must be received by the Purchasing & Procurement Department prior to 2:45 p.m. on July 19, 2019.
